The Askew Foundation, Inc., offers financial aid to NCSEA Members and Associates for NCSEA sponsored continuing education programs and for courses offered at the NAEA National Conference. All applications are reviewed by the Askew Foundation Selection Committee, and decisions will be based upon financial need, career goals, and professional experience. Only complete applications will be considered.

Oualifications:

- Applicants for Askew Foundation Scholarships for Continuing Education Courses must be a Member or Associate of NCSEA.
- Scholarships are only for Continuing Education courses offered by NCSEA or NAEA or sponsored by NCSEA. Only one scholarship a year will be awarded to any one applicant.
- Applicants must not have been awarded an NAEA Education Foundation Scholarship for the same course indicated in this application.
- The application must be complete. Thoroughness and neatness of applications will be taken into consideration in awarding the scholarships. Note this is a three-page application.
- Please do not provide any identifying information in your responses to Sections D, E, or F, or in any of the responses on page 3 of the application. Attach additional sheets as necessary, but do not put your name or identifying information on the additional sheets. You may scan your completed application and send it in a pdf format to askewfoundation@outlook.com.

All available scholarships and the application deadlines will be posted on the <u>Scholarship page</u> of NCSEA's website, <u>www.ncseaonline.org</u>. Applications received after the deadlines will not be considered. Incomplete applications will not be considered. Recipients will be notified by email. Payment will be made directly to the organization offering the continuing education course. If you have already registered and paid for the event, the amount of the award will be payable to you upon proof of payment and registration.

If you are awarded a scholarship from the NAEA Education Foundation for this course after you have submitted your application with the Askew Foundation, you will notify the Askew Foundation Committee as soon as possible. You will reimburse the Askew Foundation for any monies which have been paid on your behalf by the Askew Foundation.

Note that while any applicant may apply for as many scholarships as he/she wishes, the applicant may only receive one scholarship from the Askew Foundation per year. Scholarship applications must be received by the administrator on or before 12 noon of the deadline date.
