



**ASKEW FOUNDATION, INC.
SCHOLARSHIP APPLICATION
For Special Enrollment Exam (SEE) Preparation**

The Askew Foundation, Inc., offers scholarships for NCSEA SEE Prep Courses, NAEA Online SEE Prep Courses, and NAEA National Conference Intensive SEE Review. All applications are reviewed by the Askew Foundation Selection Committee, and awards will be based upon financial need, career goals, and professional experience. Only complete applications will be considered.

Qualifications:

- Applicants for SEE Prep Scholarships must be Associates of NCSEA, be sponsored by an NCSEA Enrolled Agent member, or be registered for NCSEA’s SEE Prep Courses.
- All applications must be accompanied by two letters of recommendation. If sponsored by an NCSEA member, one letter of recommendation must be from the member sponsor.
- You must have a high school diploma, GED, or the equivalent.
- Scholarships are only given for SEE Prep courses offered by NCSEA or NAEA.
- Applicants must not have received a NAEA-EF scholarship for the same course.
- Participants must attend and complete the entire session for which they are awarded a scholarship. Applicants may receive only one scholarship a year from the Askew Foundation.
- The application must be complete. Thoroughness and neatness of applications will be taken into consideration in awarding the scholarships. Note this is a three-page application.
- Please do not provide any identifying information in your responses to Sections D, E, F or G, or in any of the responses on page 3 of the application. Attach additional sheets as necessary, but do not put your name or identifying information on the additional sheets. You may scan your completed application and send it in a pdf format to askewfoundation@outlook.com.

Applications received after the deadlines and incomplete applications will not be considered. Recipients will be notified by email. Payment will be made directly to the sponsoring organization. If you have already registered and paid for the event, the amount of the award will be payable to you upon proof of payment, registration, and attendance.

Only one scholarship will be awarded for NAEA’s Online SEE Preparation Course and NCSEA’s Online SEE Preparation Course. Once this scholarship is awarded, no other applications will be considered for that year. We recommend that you submit your application as soon as possible once you decide to participate in the course.

If you are awarded a scholarship from the NAEA Education Foundation for the course indicated in this scholarship application after you have submitted your application with the Askew Foundation, you will notify the Askew Foundation Committee as soon as possible. You will reimburse the Askew Foundation for any monies which have been paid on your behalf by the Askew Foundation.

Applicants may receive only one scholarship per year from the Askew Foundation. Applicants may apply for as many scholarships as they wish as long as they meet eligibility requirements. Deadline for submitting applications is 12 noon on the application deadline date.

The Askew Foundation, Inc., reserves the right to require proof of attendance and completion of the course for which applicant receives a scholarship. If recipient does not complete the course, the recipient will refund AFI any scholarship monies awarded on recipient’s behalf.
